


The Infrastructure of Opportunity

- Should be as pervasive and reliable as the physical infrastructure of roads and water lines.



Infrastructure of Opportunity: Priorities and First Steps

- Commit to a common vision for creating pathways that allow more individuals to thrive
- Good planning requires engagement of the whole system, including large employers and institutions who take the lead
- Assume potential in the emergent workforce and develop the talent of all to stay competitive
- Allocate resources to reflect the challenges identified on the education-to-career continuum
- Local philanthropy can take the lead to leverage additional local, state, and federal investment

Working Families Success Network

Financial stability is:

- Earning enough income to meet daily expenses and cover minor emergencies and build assets
- Incurring smart debt
- Employment skills for resiliency
- Good relationships with mainstream financial institutions
- A postsecondary education plan for dependent children
- Realistic retirement opportunity



WFS: Integrated Service Delivery

- The WFS model *bundles* a set of three core services in a *sequenced* client flow
 - Employment and career services
 - Income and work supports
 - Financial services and asset building
- WFS is not a standalone *program*, but an *approach*—what changes is *how* services are delivered
- Service delivery can be carried out by case managers, financial coaches, and community partners

Employment & Career Services	Income & Work Supports	Financial Services & Asset Building
Educational offerings	Public benefits access	Educational workshops and financial literacy
Job training	Tax assistance	One-on-one financial coaching
Job search and placement	Student financial aid	Access to financial products

Mental Health Report

Key findings:

- Administrators are informally and formally positioned as "gatekeepers," educating students and guiding them to resources.
- Community colleges will and should vary in their approach to mental health education and services for faculty, staff, and students in order to provide resources based on challenges to health and wellbeing in the community.
- As community colleges continue to address mental health and wellbeing, scaling and sustaining efforts in this underresourced and under-researched but vital field depends on **increasing awareness**.

Next steps:

- A qualitative survey of administrators at Healthy Places
 NC Community Colleges to understand existent
 resources and practices, areas of interest, and shared
 inquiries about mental health services.
- A survey of the **NC Community College System** to identify variances in approach, demographics, and best practices throughout the state.
- A report aimed at capturing and contextualizing efforts to address need and encourage awareness, with particular focus on barriers and opportunities for rural community colleges.
